**TENDER/CALL FOR ENROLMENT INTO POSTGRADUATE STUDY PROGRAMME
IN THE ACADEMIC YEAR 2009/10**

In cooperation with University of Maribor, EMUNI University will implement the following study programme:

- Doctoral Study Programme (3rd Bologna Cycle): **Criminal Justice and Security Studies** (the programme will be implemented by EMUNI University and **University of Maribor, Faculty of Criminal Justice and Security**)

Study programme: CRIMINAL JUSTICE AND SECURITY STUDIES

Type of programme: Doctoral (3th Bologna Cycle)

Duration in academic years: 3 years, 180 ECTS

Conditions for enrolment in the 1st year of study:

- candidates who graduated from 2nd Bologna Cycle study programme
- graduates who completed study programmes which are formed for studying professions regulated by EU directives or other single cycle master study programmes which consist of 300 ECTS
- candidates who graduated from academic study programmes accepted before June 11th 2004*
- candidates who graduated from professional study programme, accepted before June 11th 2004 and a specialist study. These candidates need to fulfil study obligations in the amount of 60 ECTS before the enrolment. These obligations are the courses from the 2nd level master study programme Criminal Justice and Security Studies: Critical Thinking and Problem-Solving, Crime Investigation Strategy of Crime Reduction, Sentencing Policy and Penology, Intelligence and Security Activity, Private Security Industry, Methodology of Social Research and Applied Multivariate Statistics

Enrolment conditions fulfil also the candidates who passed education outside Slovenia that is equivalent to above mentioned.

Number of places: 10 for part time study.

Location of delivery: Ljubljana, Portorož.

Selection criteria when enrolment is restricted:

- grade point average (15 %),
- grade of final thesis (5 %) and
- success at the selective examination (80%) that consist of an examination from the field of criminal justice and security. Previous scientific and professional work related to study programme can contribute up to 50% of the examination mark.

Application procedures and application deadlines: Candidates need to fill in application for enrolment which is available through <http://www.emuni.si/en/strani/330>. Printed and signed application for enrolment must be supplemented with the following documentary evidence:

- Certified Copy of Diploma
- Diploma Supplement or the official confirmation of completed study obligations/exams (including name of study obligation, grade and the average point grade)
- Curriculum Vitae
- Motivation letter for studying (1 page)
- English language certificate
- Proofs of fulfilling other enrolment conditions (certificate of work experience related to study programme, which shall be issued by employer)
- Recommendation Letter (recommended)

Application deadline:

Students need to apply at latest by **30 September 2009**. In case same places will be available after this date, the application will be possible by **10 October 2009**.
